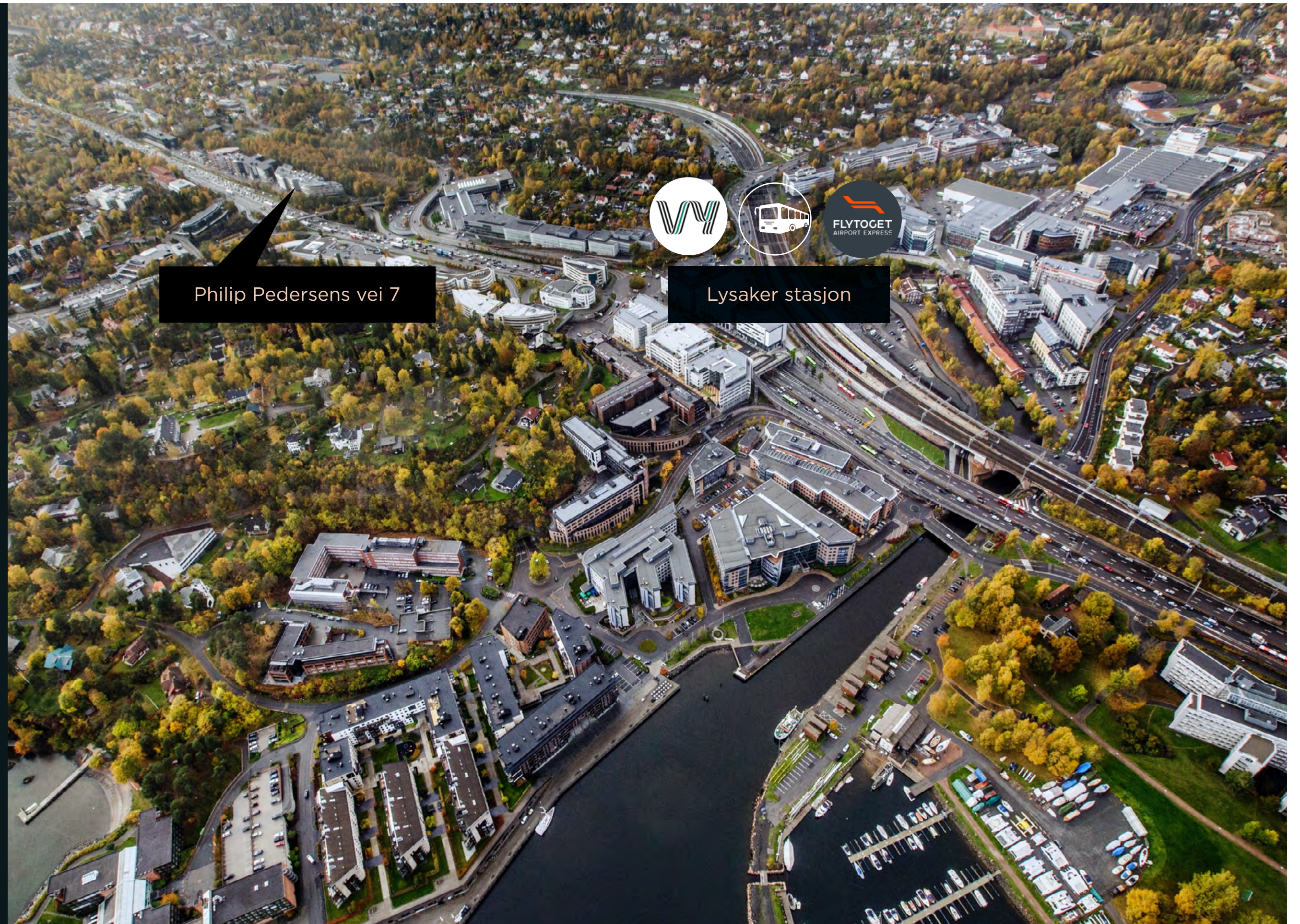


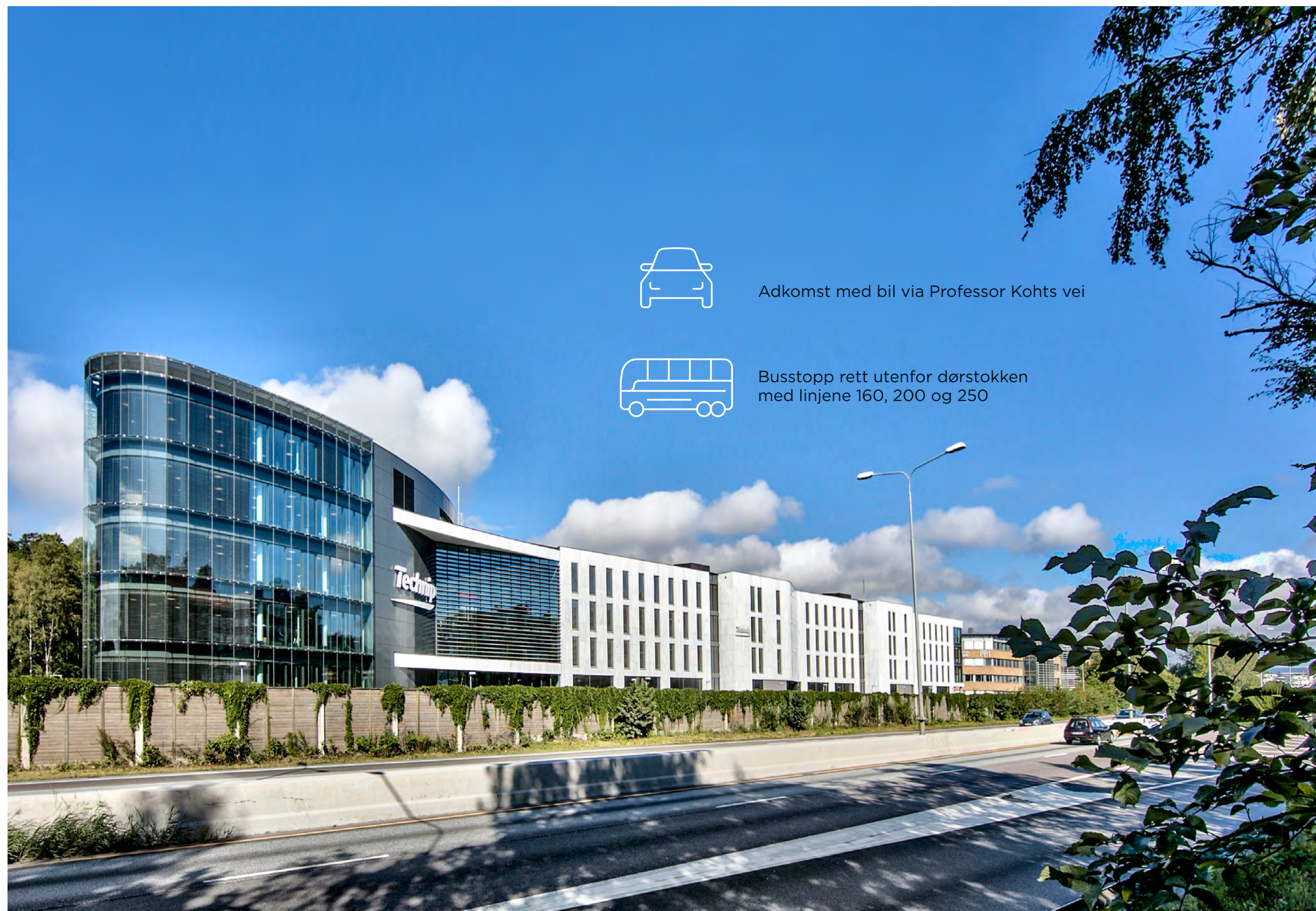
LYSAKER POLARIS

Oslo sentrum nås på ca. 4 min. med bil

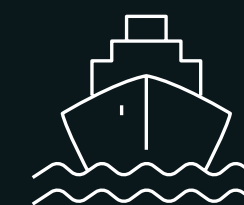




Adkomst med bil via Professor Kohts vei

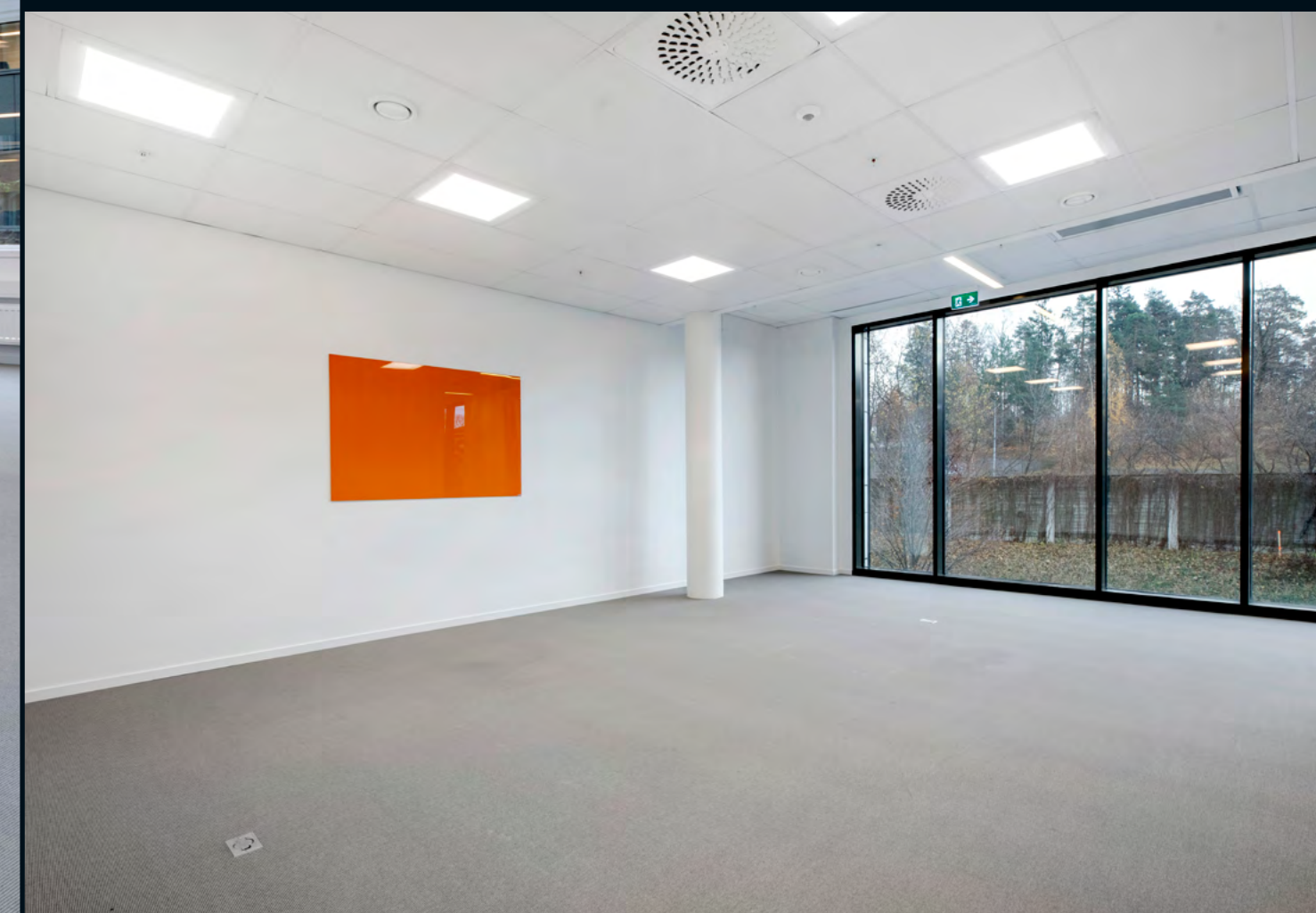

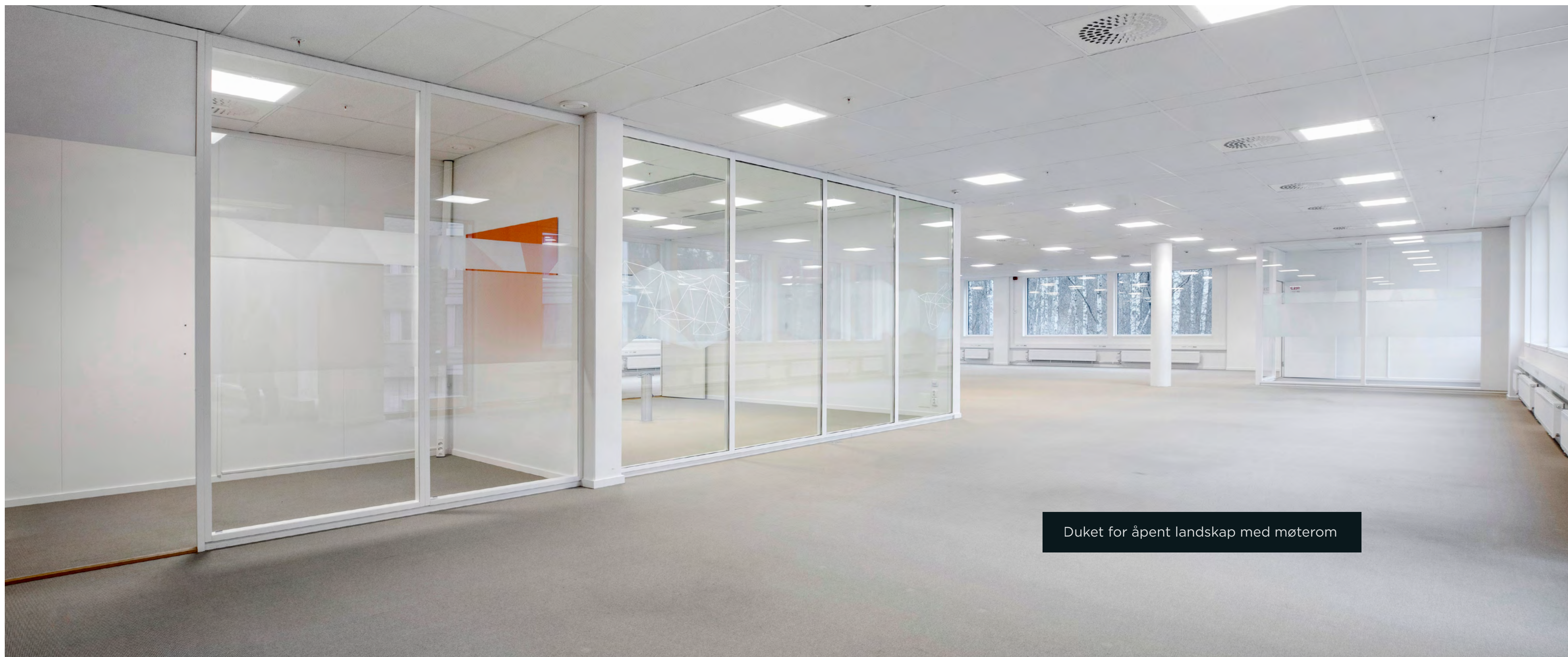

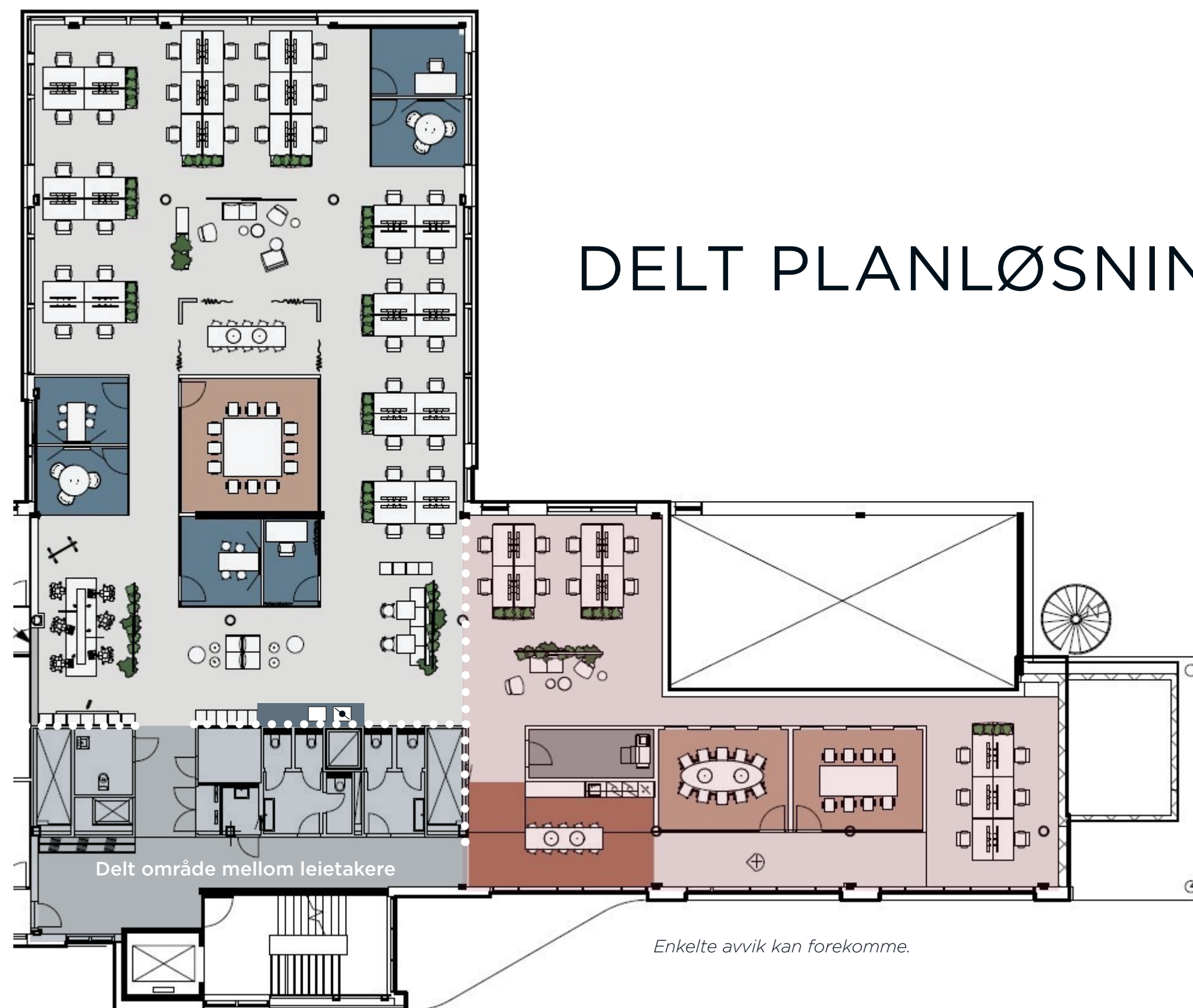
