Ved jernbanestasjonen ligger også Sandvika bussterminal (en av de største i Oslo og Akershus-området) samt taxiholdeplass.

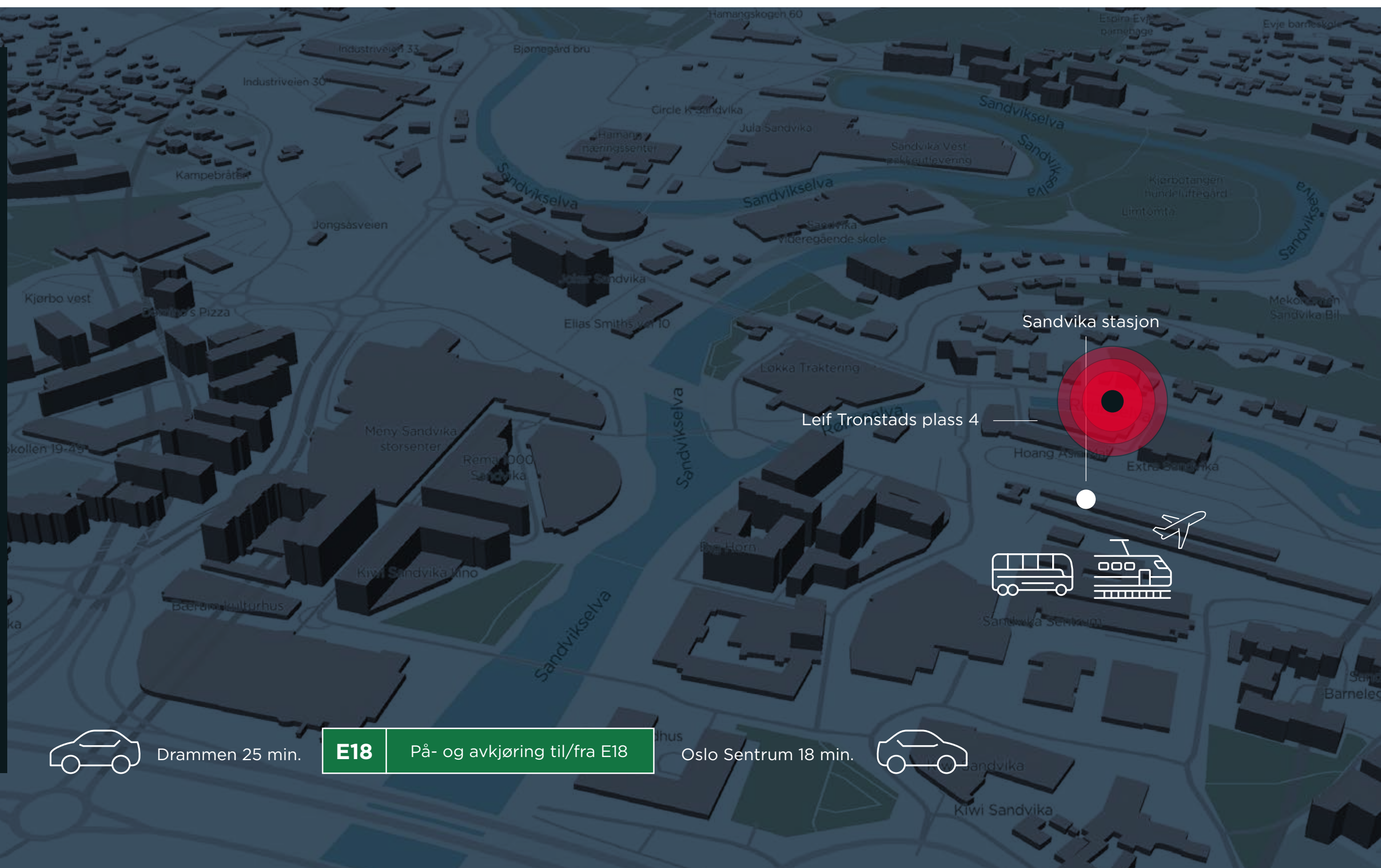

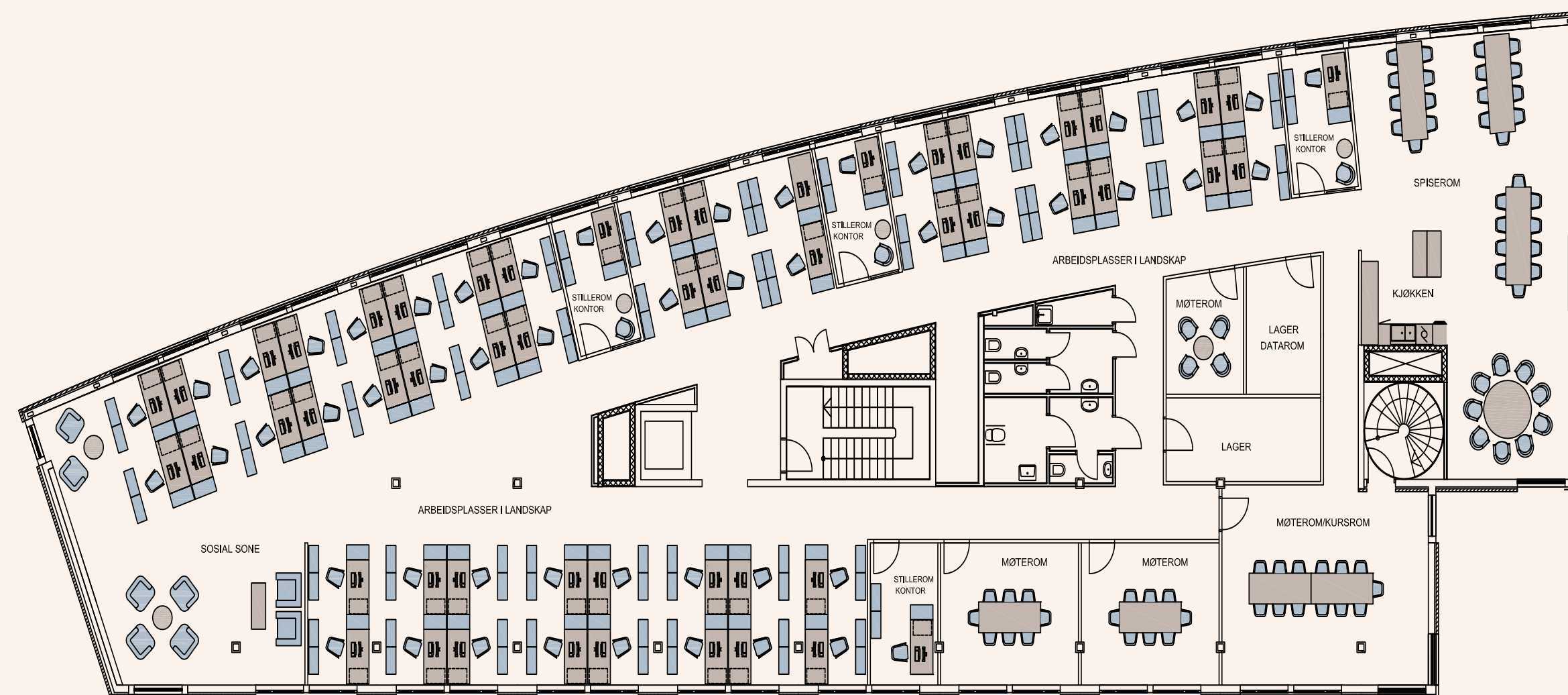

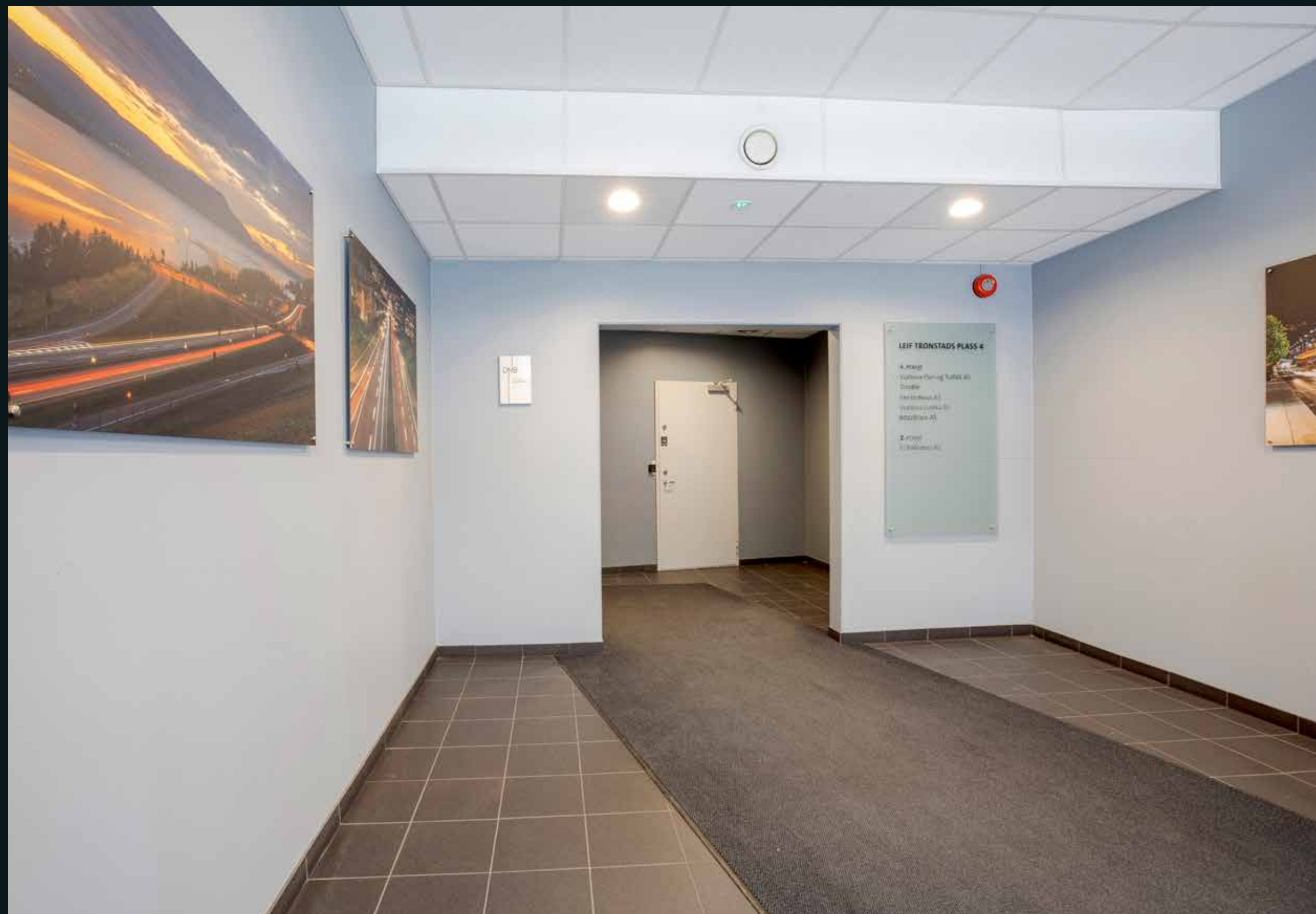
